MINUTES OF IPCE-4

4th International meeting of Paedophile and Child Emancipation organisations, held on July 8 to 10, 1990 in Amsterdam.

The program started with an informal meeting on Sundayafternoon, followed in the evening by reports from all represented countries. The following organisations were represented:

REPORTS

First the man from Project Truth/Free Will/Kids are people too told about his publicising work. This involves:

1. The magazine 'KRF2'(Kids aRe People too), aimed at same-gender-oriented (=gay) youth. The articles for this magazine are written or collected from others by a now 17 year old boy, who has been doing this work for the last three years. Adults are only doing the technical work involved.

2. Two magazines made by an adult from existing articles and newly written texts: the 'Free Will Journal' giving general information from the group, and the 'Free Will Report' with technical information, research, psychology, sociology etc.

3. Spreading booklets and copies of reports.

This information is sent to members and, more important, to many government representatives and radio/television persons who are supposed to at least read the information. Aim is of course to influence these people, who do also receive much information emphasising only the dangers for children involved in gay and/or child-adult-relations. The money comes from subscribers, donations and private money from the pople involved.

NAMBLA

The 'North American Man-Boy-Love Association' has about 550 members and is run by a Steering Committee of about 15 persons that has been rather stable during the 10 years of existence. They publicise a monthly magazine called the NAMBLA-Bulletin, and have two local chapters, in New York and in San Francisco, who organise monthly meetings visited by about 20 to 30 persons, and operate telephone-lines and mail-boxes. Other chapters unfortunately failed. The money comes mainly from the members, and in a smaller amount from the sale of publications and from donations. NAMBLA tries as far as possible to work together with gay-groups. For instance they participate in the Gay Pride March and in the Gay Press Association, and advertise in the gay press and in progressive newspapers.

PAGE :

Some questions were asked, like:

- Aren't you waking up sleeping dogs by speaking out openly on

man-boy-love?

NAMBLA (and KRP2): No, the American public is all too aware of the dangers of child abuse, whether real or imagined. But we think that the hysteria and panic have began to subside a bit. It is possible now to criticise in public the exclusively negative tales that are being told about man-boy-love.

- Why are you so successfull?

Well, we could survive. Due to determination, luck, and not being frightened at the first trouble.

- How bad is the situation in US prisons?

Bad! In jail society the boy-lover is the least respected person. Some people even die, sometimes by suicide, though others get along rather well. No numbers are known. The NAMBLA-Bulletin is sent for free to about 100-150 prisoners, as far as the State government does not prohibite this.

Denmark

There is not much activity going on, and no formal organisation exists. Only a few members try to stay together in monthly meetings in Copenhagen. But they do have successfull programs on gay radio-stations.

Two men accused of masturbating boys spoke out in Court declaring themselves paedophiles and holding a long speech about the discrimination of their sexual rights. This resulted in a sentence of some months jail unsuspended, where normally they would have gotten a fine or a suspended sentence.

Two people present at IPCE plan to start new meetings in Denmark

in september.

Question: Are there contacts with the gay movement?
- From 1983 till 1985 we were part of a gay organisation. But then the lesbians voted us out. Though unofficially we still use some of their canals.

Netherlands: Martijn

Martijn has been existing for 7 years and has now about 500 members. It publicises 6 times a year the magazine 'O.K.' (about 200 copies sold in bookshops), monthly a clippings-magazin (called 'Persfocus'), and leaflets for interested people, for parents and for children. Other activities are:

- About two times a year meetings for members with discussion

 About two times a year meetings for members with discussion and/or film. (Local meetings are organised by NVSH)

- First-line social assistance.

- Contacts with paedo-friendly lawyers.

- Informing people about paedophilia and sexual education.
- Participating in the Gay Pride Market and other markets. Beginning contacts with child-care and anti-child-abuse
- organisations, trying to influence their vision on paedophilia. Following the political discussions and trying to take part in them via COC (gay organisation).
- Financially and legally supporting civil court processes and pressing people to proceed in appropriate cases.

Martijn has a board of 6 persons and there are 6 editors and some helpers for special cases. No one gets paid. Money comes mostly from membership-fees, further from the sale of books, some donations and a fund for civil court procedures. The proposal for lowering the age of consent in The Netherlands has been taken off the agenda. According to Martijn it is waiting

for support from respected organisations before it will be reconsidered. An anti-discrimination law is in preparation. Whether this will also benefit homo-paedophiles depends on the text of the new law, but there is strong resistance against such a broad law. Possibly christian school will keep the right to refuse gay teachers.

NVSH-LWGP

NVSH is the Dutch Society for Sexual Reform; LWGP is part of it, and is a discussion-platform of 13 local work-groups in the field of paedophilia and adult-child-relations. Some are organised within NVSH, some within COC. The local groups form the heart of the organisation, they hold monthly evenings, some open, some for members only, altogether involving about 250 persons. On the national level in LWGP members exchange experiences, develop ideas, set up a documentation, make readers on several levels of education to inform people (for instance one for lawyers, courts etc.), and consult with Martijn and LWGJ (a child-emancipation group). Most local groups have contacts with their local authorities.

There exists a 'reaction network', a group of people reacting

very carefully on press publications.

The main difference between Martijn and NVSH is that Martijn is a nationwide association, and NVSH a collection of local groups.

The situation in The Netherlands, according to LWGP
The Netherlands are not the relative paradise of the seventies, nor is the oppression as strong as in the UK and the US. The age of consent is still 16 years. But, if you have a good contact with the parents, and you act very carefully, friendship with a child is possible, especially when the 'child' is 14 or 15. Some actual juridical cases: Two men were sent out of an ice-skating hall when their paedophile identity got known.

Don Mader case: see below.

Utrecht-case: pictures of the same children were found in Holland and in Britain. Was this a 'network'? No, just some friends who exchanged photos.

'Bolderkar'-case: In this child-care center 10 out of 20 children were diagnosed as cases of incest by their fathers. The children were taken out of their families, the fathers were being arrested. Untill now no case was proved, on the contrary, a movement arose against these psychologists.

Another actual point is the important movement against incest. Every schoolchild is learned to say no. In sexual education,

homosex is still considered as exceptional.

Don Mader told about his case.

Mader is an American photographer who from 1970 untill 1983 made a series of nude portraits of boys as they grow up. An exhibition of this work was held in 1979/1980 in New York City. In 1986 he moved to The Netherlands where an exposition was held in Intermale Gallery. As a result of the work of an American secret agent, the exhibition was raided and Mader and the owner of the Gallery were arrested. (No sexuality nor erections were shown on the pictures). The Dutch 'child-porn article' (240b) talks about 'sexual conduct'; thee prosecutor talked about 'pictures intended to sexually arouse people'. Mader and his lawyer challenged this interpretation; various court decisions followed, and will follow in the time to come. In april of this year, after a negative sentence for Mader, he was declared an 'undesirable person' in

The Netherlands. He appealed to this declaration as well.

Great Britain

There is no organisation, only small groups of friends who meet informally. Maybe something will again be set up in the future. The atmosphere is very negative, but not so severe as in the USA. Paedophilia gets a very bad press, with many 'affairs' that later turn out to be nonsense. Many people are sent to prison. The social-work-industry is looking for child sexual abuse everywhere.

Greece

No movement exists. Paedophilia and child-emancipation do not get much public attention, nor positive, nor negative. Sometimes hysteria flares up, but then it dies out again. The age of consent is 15, people are sent to prison for sex with youngsters. A gay movement does exist, but nothing is known about contacts with paedophiles.

Germany: Berlin

In Germany there exist different groups who do not work together, since the DSAP splitted in 1981. In Berlin three people meet monthly, The scene in East-Germany is reported to be very hard, people do not know each other, and everyone is vulnerable to blackmail. The former editor of Philius says: the magazine stopped in august 1988, because it took the only editor too much time and money; no one supported him in a useful manner. At the same time other people started the magazine Jimmy, which works purely commercially.

Pådogruppe Bremen

Meetings are held every 14 days, visited by 10-20 persons. East-Germany is considered as a great challenge here. The age of consent in the DDR is 14 now; when West-German law is taken over it will become 18! The Bremen-group is making contact with East-German gay groups. These groups meet in rooms of churches!

Pådogruppe Mänchen

The group originates from the DSAP, which flopped in 1981. Some years later, after police problems, it stopped officially, but later started again in connection with VSG. Today it is a self-help-group with 10-12 members, also from Austria. They publish no newspaper, only leaflets. There are contacts with HuK (Homosexuals and Church) and with a local gay political party.

AHS

The AHS (Arbeitsgemeinschaft Humane Sexualität) is not a paedogroup but a sexual liberation group, which contains a 'Department Child Sexuality and Paedophilia', which meets 2 to 4 times a year. They try to build up a project of lawyers interested in paedophilia, they wrote a 'Position-paper on paedophilia', and have contacts with a child-protection-association.

Nameless group

Three people told about a group that used to be a commune in Nirnberg, and now has a very loose form of organisation all over the world, and no name. They still propagate a commune-form of living, refuse completely all state structures, and do not work with compromising groups. They try to legalise run-aways, do not focus on sexual affairs but on human rights, oppose compulsory

education, and publish their ideas. Recently the group split up on the point of 'adultism'. This means: what the state defines as adult rights, that people get only because of their age. The representatives think adultism should not be tolerated.

Messages to IPCE from other countries

- In Switzerland there seem to be plans to start a new group. A meeting is reported with about 300 people.

- In Sweden as well as in Finland exist plans to set up a group.

(Contact via IPCE secretary)

- In Belgium some groups are still active. It is very difficult to work there, and they give few publicity.

- In France GRED does not exist anymore officially.

ORGANISATION OF IPCE (Monday morning)

Martijn presented a paper to the meeting, intended to give IPCE a better working structure. The paper contained four points:

(1) General,

(2) Aims of IPCE,

(3) Rules about speaking-time and voting at the annual meeting,

(4) The Secretary.

Followed a discussion about whether to accept this paper as working-rules for IPCE. Arguments mentioned in favor were: - From the many good intentions of IPCE-1989, almost nothing was realised. No one can be held responsible for this failure, because there is no organisation.

- When taking part in ILGA-conferences, it is important for paedophile and child-emancipation groups to speak with one voice, as one organisation, just like other ILGA-participants unite themselves.

For these reasons we need an IPCE-secretary, and as IPCE we must fix our aims. Martijn offers to be the secretary for the coming vear.

Arguments mentioned against the proposal were:

- Too many rules will give long disputes about formulation, will stifle the spirit; we don't want an organisation, only contact; we don't want to decide by voting, but by consensus; there are fallures in the proposed text.

Many people felt for the idea that we need a formal façade for the ILGA and the outside world, but that we don't want too much internal structure. This let to the outcome that the points (1) and (4) should be accepted (with changes in the language), and (2) and (3) should be skipped. This means we will run our meetings by consensus, and we will have no aims formulated. Whether we need these, and what they should be, can be discussed in the Newsletter. The paper, as accepted, reads (points renumbered to 1 and 2):

ORGANISATION IPCE

1.1. General.

The IPCE consists of an annual membership meeting and a secretary between meetings.

1.2. Annual meeting.

a) The annual meeting will be organised by the host organisation.

b) The host organisation for the next meeting will be determined

at the previous meeting.

c) Any involved organisation can host the annual meeting.

2. Secretary.

a) The secretary will be elected during the annual meeting.

b) Any involved organisation can serve as secretary.

c) The secretary will correspond with the IPCE organisations, and copies of correspondence between these organisations will be send to him.

d) The secretary issues invitations for the IPCE-meeting and sends the suggested agenda.

e) The secretary will contact paedophile and child emancipation organisations all over the world and exchange information with these organisations, after decision of the IPCE.

f) Recent information may (after consultation with involved IPCE members) be given to other organisations.

g) New organisations will be informed by the secretary about IPCE.

h) The secretary is responsible for the production (once every three months) of the 'IPCE Newsletter' and its distribution to all members of IPCE.

ILGA 1990 (Monday afternoon)

ILGA (International Lesbian and Gay Association) held a conference in Stockhom on July 1 to 8, 1990, where some IPCE members were present. Some remarks about this conference follow. Last year, in 1989, the Norwegian groups DNF-48 and FHO wrote a paper for ILGA that said in effect: all adult/child sex is child sexual abuse. Last year, this view was not accepted by ILGA, and all agreed to invite Dr. Theo Sandfort to speak this year (1990). This year there were 3 workshops in our field. One was experiential: both women and men spoke out and shared personal experiences - positive and negative. The whole workshop had no problem with experiences of children above 12 years of age. Pedophilia was not seen as something bad, but some age of consent was considered necessary, rather than looking at the quality of a relationship. The second workshop, on Children's Rights, was a repeat of last year's, of which the resolution was then rejected. Now FHO and DNF-48 made a final resolution out of the unofficial summary of the Declaration of Rights of the Child (from the United Nations). The workshop was loaded with women, so they were likely to get

their way. The use of the word 'abuse' was important to the Norwegians and others; despite considerable opposition from persons friendly to boy-love, this word was included in the final resolution. Some people tried to include the oppressiveness of the patriarchal family and of the unjust economic system to

children's rights in the resolution.

The third workshop was a discussion about pedophilia: the definition, women/girl relationships, age limits. People who supported the ideas of NAMBLA were: Mexicans, Catalans, COC (Dutch) and two women, one from Holland and one from Greece. Vereniging Martijn's application as ILGA-member was accepted despite the objection that they are not a gay and lesbian group. The ILGA-constitution was changed in a way to limit the membership to gay and lesbian groups. But this is not disasterous, since groups can form lesbian and gay subgroups that can apply for full membership in ILGA.

Remarks from IPCE-members: - More pedo groups should join ILGA. Not only NAMBLA should be

present.

- We should strengthen relationships with supportive ILGAmembers, and with IGLYO (the youth groups).

Next summer the ILGA conference will take place in Mexico. Before that, in december 1990, there will be a regional ILGA conference in Manchester (UK). Presence of pedo-groups there is important; Martijn and COC should present a position paper together. Maybe at the Mexico-conference, IPCE can become member of ILGA.

PRIORITIES OF IPCE (Monday morning and Tuesday morning)

In 1989, a list of 10 action points was made, of which almost nothing was realised. Therefore, this year we should concentrate on a small number of priorities. The IPCE secretary will control the realisation of these points. We shall concentrate on:

- 1. Dialogue with women.
- 2. Collecting arguments against child/adult relations.
- 3. Supporting small groups.
- 4. Collecting booktitles.
- 5. Networking.

Explanation.

- 1. Dialogue with women. Martijn has contacts with feminists, and will distribute papers on this subject to IPCE members. Paidika will publish a special issue on feminism and pedophilia. Suggested is that IPCE contacts the ILGA women's secretariat. Various people advise that talks with women should not focus on arguments, but on exchanging experiences. Let women first tell their stories, then we tell ours.
- 2. Collecting arguments. The first point let to the questions: what is pedophilia?, which arguments are used against it, and which answers can we give to these arguments? KRP2 asks everybody to try to look and listen to others and what they say about us, and to send your findings to them. They will make a list of it, and at a later conference we can think of answers.
 Apart from arguments, often there remain hate or uneasy feelings by outsiders. Then it is better to talk about personal experiences and, if possible, show a real man and boy and their relationship. Then, maybe, others get the feeling of what it is all about.

The use of the word 'pedophilia' was discussed. NVSH-LWGP does not use it anymore, it is no identity. When you talk about 'feelings of loving children', any parent can understand you. In many countries the word 'pedophile' stands for a very bad person. In parts of the USA now the word 'predator' is used. This means (approximately) a hunter or attacker. Maybe we should use this word for people who really abuse kids. 'Pedophile' should then be reserved for those who really love children. It seems that in USA and UK all pedophiles are considered sick, and ready for treatment. In The Netherlands, when relations are consensual, at a first offense judges sometimes demand a smartmoney, and order therapy, not to change the pedophile, but to

3. Supporting small groups. People in various countries need help for setting up a group or a magazine etc. The best way is that

learn him how to handle his feelings in a right manner.

they ask a specific other group for help.

General remarks: important is the building of 'base communities', these are local work-groups. In The Netherlands these local groups work together in NVSH, a national organisation with a broader goal than only pedophilia. That works good. But local groups should be the basis.

Specific requests: the British representative asks for various help. Could people come to Britain for the ILGA in Manchester and some other occasions? Could British prisoners be helped? The man from Berlin asks help to build up a group. The same question comes from Denmark. Letters from Sweden and Finland also ask help for building up groups in these countries.

- Collecting booktitles. NAMBLA's international secretary will make a top 10 book list. Everybody is asked to send him names of books.
- 5. Networking. Here is ment keeping in contact with each other. Individual persons should contact their national organisation to this end. On an international level, the organisations keep in touch via the IPCE secretary, the yearly IPCE conference, and, last-but-not-least, the Newsletter. So: please send interesting texts to Martijn (P.O. Box 43548, 1009 NA Amsterdam)

MORAL LAW IN THE NETHERLANDS

CHILD SEX.

Untill this time the Dutch law prohibits all sexual acts with children unter the age of 16. Sex with girls between 12 and 16 was only investigated when parents lodged a complaint. Sex with boys between 12 and 16 could be investigated after rumours or suspicions. Last month the State General proposed a changing in the law. Sex with boys can now only be investigated after a complaint of the parents or the boy, this is now the same as it was already for girls. The public prosecutor has now to compare if the interest of the boy or girl is served by an investigation or not.

If the sex was the free will of the child and he doesn't complain about the sexual affairs, there must be particular circumstances to investigate the affair or to press charges.

Abstract:

In general public nearly all sexual contacts between adults and children are recognized as "sexual abuse" and therefore morally condemned.

Starting point of this research is the conviction that one of the most important reasons for that social valuation is the lack of scientific knowledge about the different kinds of sexual relations between adults and children: Up to now almost violent contacts had been focused on in research, whereas next to nothing is known about loving sexual relations between children and adults. The social and sexual contacts of paedophile men and women to children have not been of any interest for research up to now.

We don't want to "prove" anything within this research project, but just come to know, how the reality of such relations really is. We want to get informed about the situation of paedophiles. How is their 'being in the world' (Wie sieht ihre Lebenswelt aus)? How does the social-sexual relation between adults and children look like? How is the everyday life in paedosexual friendships?

In detailed interviews we want to question paedophiles about their as well physical love to children. We are interested in all constellations of paedosexual contacts: man/boy, man/girl, woman/boy and woman/girl. Our research takes place far off all medical-psychiatric institutions and the activities of the authorities of criminal prosecution. The anonymity of all interviewees shall be preserved in any case.

Court Gives States Carte Blanche on Pornography

In a bitter 6-3 split, the US Supreme Court ruled April 18th that simple possession of depictions of nude minors can be banned, in a move that will probably lead to possession statutes in most states within a few years.

The decision establishes an exception to a 1969 high court ruling that declared unconstitutional a law criminalizing possession of obscene matter, and marks for the first time a decision that it is legal to ban possession of communicative material.

In the majority opionion, the six justices, led by Byron White, ruled that the state's power to control the sexual activity of young people takes precedence over the First Amendment freedom of persons to access to speech in the privacy of their home.

White's decision upheld an Ohio law making it a crime to possess or view material that portrays a minor "in a state of rudity" where that constitutes "Lwd exhibition" or "a graphic focus on the genitals."

The law makes an exception for material possessed by the child's parents or used for a "bona fide" artistic, educational or scientific purpose. In a bitter dissent, Justice Brennan, joined by Stevens and Marshall, warned that persons may be prosecuted for owning pictures of "teenagers in revealing dresses" or "even of toddlers romping unclothed." Brennan warned particularly that prosecutions could be used to persecute gay people.

Likewise, he said, "pictures of topless bathers at a Mediterranean beach," Michelangelo's nude state of David or the "depictions of nude children on the friezes that adorn our courtroom" could be deemed "lewd exhibition" or a "graphic focus" on the genitals.

"What is an acceptable artistic purpose? Would erotic art along the lines of Robert Mappelthorpe's qualify?" Brennan asked, referring to the photographer whose sexually explicit photographs has a become the subject of widespread controversy.

The case, Ohio vs. Osborne, involved Clyde Osborne, who was sentenced to six months in prison after police searched his house and found photographs of a nude 14-year-old boy.

"When speech is eloquent and the ideas expressed lofty, it is easy to find restrictions on them invalid," Brennan wrote.

"But were the First Amendment mited to such discourse, our freedo would be sterile indeed. Mr Osborn pictures may be distasteful, but a Constitution guarantees both his rig to possess them privately and his rig to avoid punishment under an over broad law."

The high court decision was shar; criticized by even mainstream ci libertarians. An May 1 editorial in t Atlanta Constitution called the ruli "unnecessary and ill-advised."

"As Justiced William Brennan wro in his dissent, mere nudity has be judged by the court as an inadequa standard for determining what pornographic. Who's to say th possession of a snapshot of a neighbor's newborn wouldn't render a Ohion. It liable to prosecution? As what of a drawing of a child nude Would that be actionable?" The edit rial went on to urge states to "be careful how they write legislation this area."

A number of state legislatures have acted already. A new Delaware law bans possession of nudity of minors a depicted for sexual stimulation of gratification, according to Ron Smith an attorney for the Deleware state. House of Representatives. The law provides for penalties of up to two years in jail and a \$1000 fine.
