### Hi! Are You 12 Years Old and Dutch?

The Netherlands passed a new law on sex offenses last week. For the first time, it will be a crime for a husband to rape his wife—or vice versa. There are tougher provisions on sexual exploitation of children age 12 to 16. But the most notable feature of the statute is one thing it makes legal: there is no penalty for having sex with someone who's willing, as long as the partner is at least 12 years old. In effect, the

Dutch have lowered the age of consent from 16 to 12.

The new law leaves it to parents, counselors and the children themselves to complain of sexual abuse involving boys or girls age 12 to 16. If no one complains, prosecutors will have no right to bring charges unless the child is under 12. "We did not debate whether or not it is good for children to have sex at these ages, but we tried to protect the child more in the

case where they are unwilling," said Justice Ministry spokesman Victor Alters.

Dutch children do not seem more sexually precocious than their neighbors. In one recent survey, 6 percent reported having had sex by the age of 13; the figure rose to 60 percent by the age of 18. The new law sailed through Parliament on a vote of 145 to 5. "We have received not a single complaint from the Dutch public," Alters said.

**Age of consent laws in various countries  
and other regulations regarding homosexuality.**

**Note:** This is my first attempt to achieve a synopsis. All informations need to be revised on possible errors, new developments, and more precise details (e.g. gay and pedophile, which are my main interest, or lesbian, which generally is not pursued in this extent by law). To know the laws is not enough, as the actual situation in a country may differ quite a lot from them.

## Sex med barn - vad anser RFSL?

RFSL:s principprogram bedömer sexuellt övergrepp och jämställer det med vilken grov misshandel som helst. "Speciellt grova är sexuella övergrepp mot barn", heter det vidare.

Förbundsstyrelsen diskuterade frågan om sex med barn den 12 december 1989, och slog fast att frågan om frivillighet i en relation mellan vuxna

och barn som sex uppstår puberteten är omöjlig att avgöra, på grund av det stora utrymmet i maktförhållandet. Vidare säger "Förbunden tar särskilt avstånd från sådana relationer och menar att den vuxne måste ta ansvar för sin barnrelation när barn inte går över gränser till det sexuella".

I en kommentar till utlåtandet säger Tobias Wikström,

förbundsstyrelsen är omöjlig att bedöma om sex med barn är frivilligt. Därmed kan man inte säga att det är möjligt. Vi är enligt oss och ska inte döma andra människor. Vi har en hel del gåtor löst genom att samta rörelsen för barnens bästa och sexuella relationer.

I november 1986 träffade Ken Olsson, 20 år, genom sitt arbete på en skola, trettonåriga Allan. Det visar sig att de båda bor i samma område, och en tid senare går de två sällskap hem. Allan frågar om han får följa med in på en kopp te. Detta blir inledningen till en lång och nära vänskapförhållande, som några år senare tar en ändrad form. Besvärskärligt: Inmaktarade känslor för Ken, problem med sociala myndigheter och polisen och slutligen landsflykt.

Ken Olsson är grovt sett en svensk medborgare. Men han är uppvuxen i riktiga England och pratar knappt svenska.

Sedan i februari har han i Stockholm, på flykt sedan - som han kallar det - de engelska myndigheternas uttalanden.

BRITISH REFUGEE EXPELLED

For over seven years he lived in Holland, S.B. (initials) he was a member of PIE the former Paedophile Information Exchange in England. He was searched for agitation of paedophile feelings. He flew to Holland and asked for an asylum. He went several time to the court for his case. Final after seven years the British government gave notice they don't want him anylonger. He wasn't searched by the police or authorities. 5 weeks ago he was arrested by the Dutch police and put on a ferry to England, he was expelled. There was no need for asylum because of the fact that he could live in free in England. On board of the ferry he was already arrested bij the British Customs. He is still in prison in England...Who dares to say we can take the British government serious? The Dutch television takes notice on this matter and in the Parliament questions were asked by members of the parliament.

DON MADER SENTENCED.

"Exciting around pictures of naked boys"  
(Headline of a Dutch Youth newspaper.)

The American photographer Donald Mader made for ten years ago in the U.S.A. pictures of naked boys, developing to mature men.

Several boys he followed with his camera during lots of years. No pornography, only the naked bodies of boys of 11, 12, 15 years of age. Three years ago he published them in a gay-galery in Amsterdam. Probably an American under cover agent went to Maders house and asked for kiddy porn. Mader send him away. The day after the police came to the galery and seized 15 of the 46 pictures. He was unfortunately the first victim of the new 1985 law which prohibited to show in public any kind of pictures showing children below 16 in an act of sexuality. The law was made to prevent sexual abuse of children. In this case it doesn't handle about abuse, but about art censorship. The question was, was this art or pornography? The public prosecutor said that these pictures were made obvious to excite the sexual lusts. That supposed aim of the photographer was the fact all handles about. Mader's defence contained also one of the boys, now an adult man, who was there to defend him. Also several artists, and a doctor where there. One of them reminded Rembrandt the famous Dutch painter, who sketched a masturbating boy...but that was and is without discussion Art.

Here the court is going over very thin ice.

Mader was sentenced mild with 500 guilders fee, or 10 days imprisonment. This all while all boys were free to pose, and even now don't complain about it, they saw Mader as a good friend, they enjoyed these photosessions!

Mader goes in appeal.
